



CCA RAFFLE RULES & ELIGIBILITY

County Corvette Association [CCA] sponsors and administers this Raffle, in part, to furnish a portion of the gross proceeds as a charitable donation to The Children's Hospital of Philadelphia [CHOP], at the Hospital of the University of Pennsylvania, Philadelphia, PA.

ELIGIBILITY: Each entrant, by entering the Raffle, agrees to abide by all of the rules and conditions contained herein, as well as all applicable local, state, and federal laws and regulations, and further agrees to release the CCA, its directors, officers, members, and agents, from any and all liability with respect to all aspects of the Raffle including, but not limited to, the selection process. The Raffle is open to any eligible person legally residing in the USA where the Raffle is not prohibited. Entrants must be 18 years of age or older, or of legal age in the state where they reside, with a minimum age of 18 in any case.

CERTIFICATE OF PURCHASE: The cost to purchase a single entry Ticket for the Raffle is in US funds only, and is not tax deductible. Any entrant may purchase more than one Ticket. An Entrant can enter the Raffle by purchasing a Ticket by sending a check to CCA, P O Box 724, Media, PA 19063. Ticket payment can be made by MasterCard, VISA, cash [in person, not through the mails], check or money order. If an Entrant's payment is dishonored by the bank for any reason, such entrant's Ticket will be declared invalid unless full and satisfactory payment is made prior to the Raffle drawing. Completed entry Ticket(s) forms must be in the possession of CCA prior to drawing. All Tickets will be handled and recorded on a first-come, first-served basis. Any Ticket forms and payments [including payments previously dishonored] received after closure of the Raffle will be returned to the entrant.

Upon receipt of a completed registration form and valid payment, a Ticket with assigned drawing number will be issued. CCA is not responsible for any damaged, illegible, late, lost, undeliverable, mishandled or misdirected mail.

CCA at its sole discretion reserves the right to reject any future requests to purchase Ticket(s) from anyone with whom CCA has experienced unsatisfactory payment. Purchase payments made before the drawing and accepted in good faith by CCA, but found to be invalid/unfunded/uncollectible after the drawing shall not release the purchaser from his/her/their obligation to make valid his/her/their purchase payment agreement/commitment.

GRAND PRIZE: The Grand Prize is a Base Model Corvette Coupe 1LT. The Base Model Chevrolet Corvette Coupe 1LT includes standard features only as designated by Chevrolet. Winner will select the color of the Corvette Coupe 1LT from the selection and availability of colors then offered by Chevrolet. Any Options or Upgrades beyond the Base Coupe 1LT may be added at the Winner's sole expense and responsibility. Pricing for options will be provided by Thomas Chevrolet or other designated Chevrolet new car dealer. **NO CASH SUBSTITUTE**

The Grand Prize Winner must take delivery of the vehicle at a dealership designated by CCA. Timing of the delivery of the vehicle will be made as soon as possible after the Raffle drawing date. CCA will not be responsible or liable for any delivery delays caused by GM, Chevrolet, their subsidiaries or suppliers, Winner's failure to respond, or any other reason.

All Prize Winner(s) is/are solely responsible for all costs associated with title, registration, licensing, insurance, delivery, transfer, and other applicable fees associated with their respective Prize, as well as for all local, state, and federal taxes, including, but not limited to, all luxury, special, and income taxes that may be applicable. Winner(s) will be required to provide CCA or its agents, two forms of valid ID one of which must be a photo ID to prove they are the person on the winning ticket, and social security number, and must complete all IRS and similar forms requested/required by CCA prior to delivery of their prize. Failure to do so within thirty [30] days of request shall result in an automatic forfeiture of such Winner's prize. CCA will then select an alternate winner from all remaining Tickets. Any successive Winner will be notified and shall have thirty [30] days to comply with all requirements.

The rights to any or all factory, dealership, or other incentives or rebates, disclosed or undisclosed, shall remain with CCA and not the Winner.

ODDS OF WINNING: A maximum number of 999 Tickets will be sold. Each Ticket represents one chance to win. You may enter as many times as you like. Chances of winning a prize depend on the number of eligible Tickets sold. For the Grand Prize, if 999 Tickets are sold your chance of winning the Grand Prize is 1 in 999.

DRAWING: Winner will be determined by random drawings from all of the eligible Tickets sold and received by the entry deadline. Winner need not be present to win. Drawing for the Grand Prize will be held at Thomas Chevrolet, Media, PA, on date provided at approximately 7:30PM, or as soon as possible thereafter in the event of delays beyond the control of CCA (i.e., weather) and the event will be open to the public.

WINNER: Winner(s) will be notified by phone, email, or by USPS mail based on the information received on the Ticket. Names of winners will be available to all media and will be available and listed on the CCA website. Winning Entrants agree to allow CCA to use their names, likeness, and any statements made by them regarding the prize for advertising or publicity purposes without any further compensation. Winner(s) may be required to complete and return an affidavit of eligibility and liability release. Failure to do so if requested, or if Winner otherwise fails to comply with these rules, and/or to make arrangements to claim his/her prize within thirty [30] days of notification will void that entry and forfeit any winnings.

AUTHORITY AND CONTROL: The decision of CCA shall be final in all matters concerning the Raffle. The Raffle is subject to the laws of the State of Pennsylvania. Void where prohibited by law.
